3. Supervising the Board of Management by the Board of Directors:

The Company's production and business activities in 2024 experienced both advantages and challenges. On the positive side, the accelerated construction progress of several key sections of the Long Thanh Airport project stabilized the consumption of stone from the Tan Cang quarry cluster, particularly from the Company's Tan Cang 1 quarry. By mid-May 2024, the Tan Cang Stone Mining Enterprise had completely sold off more than 300,000 m³ of stone inventory that had been unsold for a long time. Additionally, infrastructure projects in the Mekong Delta and Southeast regions boosted demand for stone from the Thanh Phu 1 and Thien Tan 2 quarries, significantly improving consumption. These developments contributed to the Company achieving favorable production and business results in 2024.

However, alongside these advantages, the Company faced many challenges in 2024 due to the sluggish recovery of the real estate market, unusual weather patterns involving prolonged heat and storms, and unresolved legal procedures related to land compensation, quarry expansion, land leases, and mineral exploitation license renewals. The inconsistent resource tax calculation methods among enterprises in the province further complicated matters. For example, the Soklu 5 quarry's exploitation license expired in July 2024, and Soklu 2's license will expire in February 2025. Although the Company submitted renewal

applications for both, the Department of Natural Resources and Environment returned the applications, citing the need to await guidance from the Ministry of Natural Resources and Environment based on Government Inspectorate Conclusion No. 1896/KL-TCP dated August 22, 2023. Additionally, the clearance and consumption of overburden soil and weathered stone from the Tan Cang 1, Thien Tan 2, and Thanh Phu 1 quarries have been delayed since early 2024 due to a lack of cost-effective solutions. This is largely due to directives from the Provincial People's Committee that filler materials of adequate quality must first be supplied to the Bien Hoa-Vung Tau Expressway project. Materials of insufficient quality are prioritized for state-funded projects before being allocated to other local projects. This has increased costs for the Company due to additional transport and disposal expenses for overburden or storing it within the mining area to make room for material extraction. Furthermore, geopolitical instability and escalating military conflicts in certain countries and regions have posed global risks, disrupting stability and development. These issues, combined with rising prices of materials and input costs, have adversely affected the Company's production and business operations.

Despite these challenges, thanks to accurate forecasting and meticulous planning, along with decisive, synchronized, and appropriate measures implemented by the Executive Board at specific times, the Company exceeded its performance targets for 2024.

The Executive Board frequently reported the Company's management and operations to the Board of Directors, sought guidance and direction, and ensured compliance with legal requirements for disclosing information on the Company's activities.
