In addition, the adjustment of the Vietnamese Dong exchange rate to maintain competitiveness for exports also increases import costs. In this context, the Company's Board of Management has flexibly adapted to market fluctuations, strived to maintain stable operations and effectively implemented the strategic policies of the Board of Directors, while ensuring strict compliance with legal regulations.
