3. Supervisory Activities of the Board of Directors over the Executive Board:

- The Board of Directors organizes regular or ad-hoc meetings to share updates on global and domestic market trends, international and Vietnamese legal policies affecting the textile and garment industry, as well as the industry's development trends. At the same time, the Board provides strategic market directions aligned with Garment Corporation 10's operations for the upcoming period.
- During Board meetings, the Executive Board reports on the advantages and challenges faced, analyzes the performance of business results, investment

activities, labor conditions, and social welfare activities on a quarterly and annual basis, while also presenting plans and solutions for the next period's tasks.

In 2024, the market has shown signs of recovery in terms of production volume; however, the orders are smaller, with lower unit prices, urgent delivery times, labor shortages, and rising labor costs. Major customers are facing business difficulties and are undergoing restructuring, which poses a risk for the Corporation in terms of debt recovery.

- The Board of Directors has instructed the CEO to focus on leadership and direction: being flexible in business strategies and production organization, switching product lines, reducing costs, diversifying products and markets, promoting digital transformation, renewing technology, investing in sustainable development programs, and green transformation. Additionally, emphasis has been placed on training, improving labor productivity, and strengthening cost management to enhance efficiency in business operations.

4. Activities of Subcommittees under the Board of Directors (if any):

According to the current organizational structure, the Organization and Administration Department assists the Board of Directors in its duties. The department has monitored and organized, as well as prepared minutes for the General Meeting of Shareholders, Board of Directors meetings, annual and mid-term review conferences, etc.
