This was achieved through various monitoring tools and oversight of the business and production activities carried out by the Board of Management in 2024, as follows:

### ❖ Supervision of Business Strategy Implementation and Financial Planning

- Presided over, directed, and successfully organized the collection of shareholders' written opinions on February 22, 2024, and the 2024 Annual General Meeting of Shareholders (AGM) on April 25, 2024.

- Periodically held meetings with the Board of Management to evaluate business performance, analyze market developments, and make timely decisions on key policies and directions to ensure that revenue, profit, and growth targets are met according to schedule.

- Closely monitored budget implementation and financial management to ensure compliance with internal regulations and minimize financial risks.

- Supervised the resolutions of AGM and BoD related to issuing new shares for

existing shareholders.

- Oversaw the periodic interest payments on bonds and the early redemption of bonds according to issuance plans.

- Directed and monitored the strict compliance with the preparation of annual financial reports, quarterly financial reports, and annual reports as required.

- Selected an auditing firm to audit the Company’s financial statements for 2024.

#### 3. Supervising the BoD, the BoM and shareholders by the BoS
