Profit after tax in the first quarter of 2025 reached VND 6.2 billion, an increase of 86.4% compared to the first quarter of 2024, mainly due to:

- The market situation in Q1/2025 is more favorable than the same period last year, leading to net revenue in Q1/2025 increasing by 57 billion, equivalent to an increase of 8.2% over the same period.
- In addition, the Company applies many measures to save costs. Operating expenses on revenue in Q1/2025 decreased by 0.97% compared to Q1/2024.
