**On the approval of transaction system connection
to the Hanoi Stock Exchange**

Pursuant to Decision No. 01/QĐ-HĐTV dated June 30, 2021 of the Members' Council of the Vietnam Stock Exchange on the establishment of the Hanoi Stock Exchange;

Pursuant to the Charter on the organization and operation of the Hanoi Stock Exchange promulgated together with Decision No. 08/QĐ-HĐTV dated July 9, 2021 of the Members' Council of the Vietnam Stock Exchange;

Pursuant to the Law on Securities No. 54/2019/QH14 dated November 26, 2019;

Pursuant to Decree No. 155/2020/NĐ-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities;

Pursuant to Decree No. 245/2025/NĐ-CP dated November 19, 2025 of the Government amending and supplementing a number of articles of Decree No. 155/2020/NĐ-CP dated December 31, 2020;

Pursuant to Decree No. 153/2020/NĐ-CP dated December 31, 2020 of the Government regulating the offering and trading of privately placed corporate bonds in the domestic market and the offering of corporate bonds to the international market;

Pursuant to Decree No. 65/2022/NĐ-CP dated September 16, 2022 of the Government amending and supplementing a number of articles of Decree No. 153/2020/NĐ-CP dated December 31, 2020;

Pursuant to Decree No. 08/2023/NĐ-CP dated March 5, 2023 of the Government amending, supplementing, and suspending the implementation of a number of provisions of decrees regulating the offering and trading of privately placed corporate bonds in the domestic market and the offering of corporate bonds to the international market;

Pursuant to Circular No. 30/2023/TT-BTC dated May 17, 2023 of the Minister of Finance guiding the registration, depository, exercise of rights, transfer of ownership, settlement of transactions, and organization of the trading market for privately placed corporate bonds in the domestic market;

Pursuant to the Regulations on membership for trading of privately placed corporate bonds of the Vietnam Stock Exchange promulgated together with Decision No. 55/QĐ-SGDVN dated July 10, 2023 of the Director General of the Vietnam Stock Exchange;

Pursuant to Decision No. 59/QĐ-HĐTV dated October 13, 2025 of the Members' Council of the Vietnam Stock Exchange amending and supplementing a number of articles of the

Regulations on membership for trading of privately placed corporate bonds promulgated together with Decision No. 55/QĐ-SGDVN dated July 10, 2023;

Pursuant to the Regulations on information technology systems for transaction system connection to the Ho Chi Minh Stock Exchange and the Hanoi Stock Exchange promulgated together with Decision No. 25/QĐ-HĐTV dated April 18, 2025 of the Members' Council of the Vietnam Stock Exchange;

Pursuant to Decision No. 97/QĐ-SGDVN dated December 30, 2025 of the Director General of the Vietnam Stock Exchange on approving special trading membership for privately placed corporate bonds for Ho Chi Minh City Development Joint Stock Commercial Bank;

At the proposal of the Director of the Bond Market Department,

DECIDES:

Article 1. To approve Ho Chi Minh City Development Joint Stock Commercial Bank to connect its transaction system to the privately placed corporate bond market at the Hanoi Stock Exchange.

Article 2. Ho Chi Minh City Development Joint Stock Commercial Bank shall comply with the provisions of law in trading activities in the privately placed corporate bond market, regulations on trading, and the Regulations on information technology systems for transaction system connection to the Ho Chi Minh Stock Exchange and the Hanoi Stock Exchange promulgated by the Vietnam Stock Exchange.

Article 3. This Decision shall take effect from the date of signing. The Director of the General Affairs Department, the Director of the Bond Market Department, the Heads of relevant professional departments, and Ho Chi Minh City Development Joint Stock Commercial Bank shall be responsible for the implementation of this Decision.
