## DECISION

### On amendment of location for the head office in the Establishment and Operation License of Fortune Vietnam Joint Stock Commercial Bank

#### THE GOVERNOR OF THE STATE BANK OF VIETNAM

*Pursuant to the Law on the State Bank of Vietnam No. 46/2010/QH12;*

*Pursuant to the Law on Credit Institutions No. 32/2024/QH15 as amended and supplemented by Law No. 96/2025/QH15;*

*Pursuant to Decree No. 26/2025/NĐ-CP of the Government stipulating the functions, duties, powers, and organizational structure of the State Bank of Vietnam;*

*Pursuant to Circular No. 50/2018/TT-NHNN of the Governor of the State Bank of Vietnam on the application dossier, order, and procedures for approving certain changes of commercial banks and branches of foreign banks, as amended and supplemented by Circular No. 06/2022/TT-NHNN and Circular No. 22/2024/TT-NHNN;*

*Pursuant to Circular No. 50/2025/TT-NHNN of the Governor of the State Bank of Vietnam on the application dossier and procedures for approving certain changes of commercial banks and branches of foreign banks;*

*Pursuant to Circular No. 34/2024/TT-NHNN of the Governor of the State Bank of Vietnam on re-issuance of licenses, supplementation of licensed activities, and the organization and operation of commercial banks, branches of foreign banks, and representative offices in Vietnam of foreign credit institutions and other foreign organizations engaged in banking activities, as amended and supplemented by Circular No. 66/2025/TT-NHNN;*

*Considering the proposal of Fortune Vietnam Joint Stock Commercial Bank in Document No. 3114/2026/LPBank.CMD dated 22/01/2026, Document No. 5064/2026/LPBank.CMD dated 05/02/2026, and the accompanying dossier;*

*At the request from the Director General of the Agency for Supervision and Inspection of Credit Institutions.*

## DECIDES:

**Article 1.** To amend the information on the head office address of Fortune Vietnam Joint Stock Commercial Bank in Clause 2, Article 1 of the Establishment and Operation License No. 91/GP-NHNN dated March 28, 2008, issued by the Governor of the State Bank of Vietnam, as follows:

“2. Head office address: No. 8, Alley 1, Ton Duc Thang Street, Quarter 11, Hoa Lu Ward, Ninh Binh Province.”



**Article 2.** Fortune Vietnam Joint Stock Commercial Bank shall be responsible for carrying out the procedures stipulated in Clause 4, Article 37 of the Law on Credit Institutions No. 32/2024/QH15 dated January 18, 2024 (as amended and supplemented) and relevant legal regulations regarding the change specified in Article 1 of this Decision.

**Article 3.** This Decision shall take effect from the sign-off date and is an integral part of Establishment and Operation License No. 91/GP-NHNN dated 28/03/2008, issued by the Governor of the State Bank of Vietnam.

Decision No. 1255/QĐ-NHNN dated 30/06/2023, of the State Bank of Vietnam on amending the Establishment and Operation License of Fortune Vietnam Joint Stock Commercial Bank ceases to be effective from the effective date of this Decision.

**Article 4.** The Chief of Office of the State Bank; the Director General of the Agency for Supervision and Inspection of Credit Institutions; the Chairman and members of the Board of Directors; the Head and members of the Supervisory Board; and the General Director of Fortune Vietnam Joint Stock Commercial Bank shall be responsible for implementation of this Decision.
