Pursuant to the Internal Corporate Governance Regulation issued under Resolution No. 02/NQ-GD dated 21 April 2022 of the General Meeting of Shareholders of Gia Dinh Water Supply Joint Stock Company.

At the first meeting of the Board of Directors in 2026, held on 04 February 2026, the Board reviewed and considered the reports and proposals and resolved on the following matters:

1. Report on business performance in 2025 and business orientation for 2026;
2. Financial Statements for the year 2025 (unaudited, for the period from 01 January 2025 to 31 December 2025);
3. Report of the Supervisory Board on operational performance and business results for Q4 2025;
4. 2025 Annual Report of the Internal Audit Department;
5. Draft Internal Audit Plan for 2026;
6. Proposal for approval of the 2026 Production – Business – Construction Investment – Procurement – Non-Revenue Water Reduction – Financial Plan;
7. Proposal for organization of the 2026 Annual General Meeting of Shareholders (AGM);
8. Proposal for temporary advance appropriation of the Salary and Remuneration Fund for employees in 2026;
9. Proposal for adjustment of the 2025 wholesale clean water purchase price;
10. Proposal for the projected wholesale clean water purchase and sale price for 2026.

RESOLUTION:

1. To approve Report No. 159/BC-GD dated 21 January 2026 on the business performance in 2025 and the business orientation for 2026 (including unaudited figures for the period from 01 January 2025 to 31 December 2025), in which the clean water output (Grade 1 standard) reached 55,122 million m³, achieving 98,78% of the annual target; the Non-Revenue Water (NRW) ratio was 9,78%, 0,82% lower than the 2025 target and 0,48% lower than the same period in 2024; profit before tax amounted to 50,686 billion VND, achieving 100,29% of the annual target. Taxes, fees and collected wastewater service charges remitted totaled 260,834 billion VND, reaching 103,46% of the annual target, representing an increase of 15,72% (equivalent to 35,435 billion VND) compared to 2024 (*Appendix 1 attached*).

In general assessment of the 2025 performance, with the strong efforts of the Management and all employees, the Company continued to ensure its key objectives, including maintaining continuous and safe water supply, sustainably achieving 100% household access to clean water, ensuring network and customer data security, maintaining profitable operations, ensuring sound cash flow management, preserving and developing capital, and fulfilling its obligations to the State and shareholders.

2. The Board of Directors unanimously approves the 2025 Annual Report of the Internal Audit Department and the 2026 Internal Audit Plan. The Internal Audit Department is assigned to develop detailed audit programs prior to the implementation of audit activities in order to ensure operational effectiveness and maintain proper coordination with the Company's relevant departments.

3. To approve the 2026 Production – Business – Construction Investment – Procurement – Non-Revenue Water Reduction Plan in accordance with Proposal No. 160/TTr-GD-KHVT. With respect to the 2026 Financial Plan, the Board assigns the Management to further review and submit it at the Board of Directors' meeting in March 2026 (*Appendices 2, 3, and 4 attached*).

4. To approve the Plan for organization of the 2026 Annual General Meeting of Shareholders (AGM). The General Director is assigned to direct the completion of meeting materials for submission to the AGM, ensure information disclosure in compliance with prevailing regulations, and organize the 2026 AGM in accordance with the Regulation on Organization and Attendance of the General Meeting of Shareholders issued under Decision No. 14/QĐ-GĐ-TCHC dated 15 March 2013 of Gia Dinh Water Supply Joint Stock Company. Any amendments or supplements to the meeting agenda prior to the AGM shall be fully notified to the members of the Board of Directors in accordance with regulations.

5. To approve Proposal No. 119/TTr-GD dated 16 January 2026 regarding the temporary advance appropriation of the Salary and Remuneration Fund for payment to the Company's employees in 2026.

6. With respect to the wholesale clean water purchase and sale price between Gia Dinh Water Supply Joint Stock Company and Saigon Water Corporation (SAWACO), the members of the Board of Directors (excluding four members having related interests) unanimously approved the adjustment of the 2025 wholesale clean water purchase price to **6.636,91 VND per m³** in accordance with Proposal No. 127/TTr-GD dated 22 January 2026, pursuant to the authorization under Resolution No. 05/NQ-GD dated 08 May 2025 of the 2025 Annual General Meeting of Shareholders (Fiscal Year 2024) of Gia Dinh Water Supply Joint Stock Company).

7. With respect to the wholesale clean water purchase and sale price for 2026, as this matter falls under the authority of the 2026 Annual General Meeting of Shareholders, the Board of Directors temporarily records, in accordance with Proposal No. 128/TTr-GD dated 22 February 2026, a provisional unit price of **6.636,91 VND per m³** for the period from billing cycle 01/2026 to billing cycle 04/2026 (until the 2026 Annual General Meeting of Shareholders is convened).
