DECISION

Administrative penalties for violations in the field of Planning and Investment

DIRECTOR OF THE HANOI DEPARTMENT OF FINANCE

- Pursuant to Article 57, Article 68, Article 70, Article 78, and Article 85 of the Law on Handling of Administrative Violations 2012 (amended and supplemented in 2020 and 2025);
- Pursuant to Decree No. 118/2021/ND-CP dated December 23, 2021, as amended and supplemented by several articles of Decree No. 68/2025/ND-CP dated March 18, 2025, of the Government detailing several articles and measures for the implementation of the Law on Handling of Administrative Violations;
- Pursuant to Decree No. 189/2025/ND-CP dated July 01, 2025, of the Government detailing the Law on Handling of Administrative Violations regarding the authority to impose administrative penalties;
- Pursuant to Decree No. 122/2021/ND-CP dated December 28, 2021, of the Government providing regulations on administrative penalties in the field of planning and investment;
- Pursuant to Decision No. 55/2025/QĐ-UBND dated September 19, 2025, of the Hanoi People's Committee on the functions, duties, powers, and organizational structure of the Hanoi Department of Finance;
- Pursuant to Decision No. 1189/QĐ-STC dated January 26, 2026, of the Hanoi Department of Finance on the delegation of authority to impose administrative penalties;
- Based on Explanation Letters No. 053/2026/BC-VFC/DA dated April 10, 2026, and No. 055/2026/BC-VFC/DA dated April 20, 2026, of Vinafco Joint Stock Corporation and the records and documents included in the administrative penalty file;
- Based on Administrative Violation Minutes No. 133/BB-VPHC established at 9:30 AM on May 05, 2026, between the Hanoi Department of Finance and the Investor/Economic Organization.

DECISION

Article 1: Impose administrative penalties on the Economic Organization implementing the Trau Quy Gia Lam Truck Terminal and Public Services Project.

1. Information of the Economic Organization:

Vinafco Joint Stock Corporation: Business Registration Certificate No. 0100108504, issued for the first time on February 12, 2001 by the Business Registration and Corporate Finance Division - Hanoi Municipal Department of Finance, with the 32nd amendment registered on August 14, 2025.

Legal Representative: Mr. Bui Minh Hung; Date of birth: September 21, 1977; Nationality: Vietnamese; Personal Identification Number: 022077003303; Title: General Director

2. Has committed administrative violations in the course of implementing the Trau Quy Gia Lam Truck Terminal and Public Services Project; Investment Certificate No. 0112100349, first certified by the Municipal People's Committee on November 16, 2009, specifically:

2.1 Failure to carry out procedures for adjusting the Investment Certificate in cases where adjustments to the investment project result in changes to the contents of the Investment Certificate:

- Failed to carry out procedures for adjusting the Investment Certificate in cases where adjustments to the investment project result in changes to the contents of the Investment Certificate (failure to adjust the project implementation schedule).

- Stipulated in: Point b, Clause 2, Article 17 of Decree No. 122/2021/ND-CP dated December 28, 2021 of the Government on sanctioning administrative violations in the field of planning and investment.

- Aggravating circumstances: None.

- Mitigating circumstances: Proactively provided complete documentation and records for consideration of administrative violation handling.

- Applied penalty: Monetary fine of VND 77,500,000 (Seventy-seven million, five hundred thousand Vietnamese Dong).

- Remedial measures: Compelled to carry out procedures for adjusting the Investment Certificate.

2.2 Failure to comply with the prescribed investment activity reporting regime:

- Failure to comply with the investment activity reporting regime with respect to quarterly and annual investment activity reports from Q4/2009 to Q1/2026.
- Stipulated in: Point a, Clause 2, Article 15 of Decree No. 122/2021/ND-CP dated December 28, 2021 of the Government on sanctioning administrative violations in the field of planning and investment.
 - Aggravating circumstances: Repeated administrative violations.
 - Mitigating circumstances: Proactively provided complete documentation and records for consideration of administrative violation handling.
 - Applied penalty: Monetary fine of VND 40,000,000 (Forty million Vietnamese Dong).
 - Remedial measures: Required to submit supplementary quarterly and annual investment activity reports from Q4/2009 to Q1/2026 on the National Information System on Foreign Investment (submitted online)

2.3 Failure to comply with the prescribed periodic investment monitoring and evaluation reporting regime:

- Failure to comply with the prescribed periodic investment monitoring and evaluation reporting regime for the 6-month and full-year periods of 2025.
- Stipulated in: Point b, Clause 1, Article 15 of Decree No. 122/2021/ND-CP dated December 28, 2021 of the Government on sanctioning administrative violations in the field of planning and investment.
 - Aggravating circumstances: Repeated administrative violations.
 - Mitigating circumstances: Proactively provided complete documentation and records for consideration of administrative violation handling.
 - Applied penalty: Monetary fine of VND 25,000,000 (Twenty-five million Vietnamese Dong).
 - Remedial measures: Required to submit supplementary investment monitoring and evaluation reports for the 6-month and full-year periods of 2025 on the Municipal Investment Project Information Management System (submitted online).

3. Total penalties applied:

- a. Primary penalty: Monetary fine, specifically in the amount of VND 142,500,000 (One hundred and forty-two million, five hundred thousand Vietnamese Dong).
- b. Remedial measures:
 - Compelled to carry out procedures for adjusting the Investment Certificate.

- Required to submit supplementary quarterly and annual investment activity reports from Q4/2009 to Q1/2026 on the National Information System on Foreign Investment (submitted online).

- Required to submit supplementary investment monitoring and evaluation reports for the 6-month and full-year periods of 2025 on the Municipal Investment Project Information Management System (submitted online).

Article 2: This Decision takes effect from the date of signing.

Article 3: This Decision shall be:

1. Delivered to the legal representative of Vinafco Joint Stock Corporation for compliance.

The economic organization named in Article 1 must strictly comply with this Sanctioning Decision. If the economic organization fails to voluntarily comply within the prescribed time limit, it shall be subject to coercive enforcement in accordance with the provisions of law.

The economic organization must pay the fine into the account: State budget revenue, account number: 7111, at the State Treasury Region I (No. 18 Giai Phong Street, Kim Lien Ward, Hanoi); chapter: 418, item: 4250, sub-item: 4278, revenue management agency code: 1058986 (or paid at banks authorized by the State Treasury Region I to collect administrative violation fines according to the above-mentioned fine payment account information) within 10 days from the date of receipt of the Sanctioning Decision, and send the fine collection receipt (copy 3) to the Hanoi Municipal Department of Finance (Van Ho Inter-agency Complex, No. 52 Le Dai Hanh Street, Hai Ba Trung Ward, Hanoi).

Vinafco Joint Stock Corporation has the right to lodge a complaint against this Decision in accordance with the provisions of law.

2. Sent to the State Treasury Region I for fine collection.

3. Sent to Vinafco Joint Stock Corporation for implementation.

4. Sent to the Office of the Department of Finance for information and coordination in implementation.
