## DECISION

**On the approval of the extension of the Certificate of Registration for additional public offering of shares of PTM Automobile Service, Trading and Manufacturing Joint Stock Company**

### THE CHAIRPERSON OF THE STATE SECURITIES COMMISSION OF VIETNAM

*Pursuant to the Law on Securities No. 54/2019/QH14, as amended and supplemented by Law No. 56/2024/QH15 (hereinafter referred to as the “Law on Securities”);*

*Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities, as amended and supplemented by Decree No. 245/2025/ND-CP;*

*Pursuant to Circular No. 118/2020/TT-BTC dated December 31, 2020 of the Minister of Finance providing guidance on a number of matters relating to securities offering and issuance, public tender offers, share repurchases, registration of public companies and deregistration of public company status, as amended and supplemented by Circular No. 115/2025/TT-BTC;*

*Pursuant to Decision No. 686/QĐ-BTC dated February 28, 2025 of the Ministry of Finance prescribing the functions, duties, powers and organizational structure of the State Securities Commission of Vietnam;*

*Pursuant to the Certificate of Registration for Additional Public Offering of Shares No. 36/GCN-UBCK dated February 5, 2026 issued by the Chairperson of the State Securities Commission of Vietnam;*

*Considering Official Letter No. 0105/2026/CV-PTM dated May 4, 2026 of PTM Automobile Service, Trading and Manufacturing Joint Stock Company regarding the extension of the public offering period of shares;*

### DECIDES:

**Article 1.** To approve the extension of the Certificate of Registration for Public Offering of Shares for:
