## **RESOLUTION**

**Article 1. Approval of the implementation of the plan to issue shares to increase charter capital in 2026, as approved by the 2026 Annual General Meeting of Shareholders, specifically:**

**I. Plan to issue shares to increase charter capital from owner's equity**

1. Name of shares: Shares of Tam Duc Cardiology Hospital Joint Stock Company
2. Type of Shares: Ordinary Shares
3. Par Value of Shares: VND 10,000 per share
4. Number of Shares Expected to be Issued: 15,552,000 shares
5. Total Issuance Value at Par: VND 155,520,000,000





6. Issuance Ratio (number of shares expected to be issued/number of shares outstanding): 100%
7. Exercise Ratio: 1:1. On the record date for exercising rights, shareholders owning 1 share will receive 1 additional new share.
8. Source of Issuance Funds: From owner's equity based on the 2025 audited financial statements, specifically:
  - Utilizing share premium: VND 1,407,488,000.
  - Utilizing the development investment fund: VND 16,603,467,737.
  - Utilizing undistributed profit after tax: VND 137,509,044,263.
9. Expected Issuance Timeframe: Expected in Quarter 2 to Quarter 3 of 2026, following notification from the State Securities Commission regarding the receipt of comprehensive issuance report documents..

For clarification, the final date of the issuance of shares to increase capital from the owner's equity (the final registration date for rights allocation) must be ensured before the conclusion of the issuance of bonus shares under the employee stock option program (the date of issuance of bonus shares to employees) as stated in Section II of this Article.
10. Plan for handling fractional shares, odd shares: As the exercise ratio is 1:1, no fractional shares will arise.

## **II. Plan for the issuance of bonus shares under the employee stock option program**

1. Name of shares: Shares of Tam Duc Cardiology Hospital Joint Stock Company
2. Type of Shares: Ordinary Shares
3. Par Value of Shares: VND 10,000 per share
4. Number of Shares Expected to be Issued: 700,000 shares.
5. Issuance Price: Not applicable (the company awards shares to employees).
6. Total Issuance Value at Par: VND 7,000,000,000
7. Issuance Ratio (number of shares expected to be issued/number of shares outstanding): 4.50%
8. Source of Funds (in case of issuing bonus shares to employees): From the owner's equity based on the 2025 audited financial statements, specifically:
  - Utilizing undistributed profit after tax: VND 7,000,000,000.
9. Transfer Restriction: All bonus shares issued under the employee stock option program will be subject to a transfer restriction for one year from the conclusion of the issuance.

Bonus shares issued will not be revoked in the event that employees resign during the transfer restriction period.
10. Expected Issuance Timeframe: Anticipated in Quarter 2 to Quarter 3 of 2026, following notification from the State Securities Commission regarding the receipt of comprehensive issuance report documents.

For clarification, the final date of the issuance of shares to increase capital from the owner's equity (the final registration date for rights allocation) as stated in Section I of this Article must be ensured before the conclusion of the issuance of bonus shares under the employee stock option program (the date of issuance of bonus shares to employees).

11. Plan for handling in the event of non-distribution: Should employees refuse to accept bonus shares (if any), the number of bonus shares for employees will be canceled and not redistributed to other parties.

*The Board of Directors VII.13 unanimously approved the implementation of the plan for the issuance of shares to increase charter capital for 2026 as approved by the 2026 Annual General Meeting of Shareholders.*

**Article 2. Approval of the list of employees eligible to participate in the employee stock option program and the number of shares allocated to each individual based on the criteria approved by the 2026 Annual General Meeting of Shareholders (List attached to this Resolution).**

*The Board of Directors VII.13 unanimously approved the list of employees eligible to participate in the employee stock option program and the number of shares allocated to each individual based on the criteria approved by the 2026 Annual General Meeting of Shareholders.*

*Members of the Board of Directors listed above shall not participate in the voting on the issuance to that Board member.*

**Article 3. Approval of the Plan to ensure compliance with regulations on foreign ownership ratio, specifically:**

- The maximum foreign ownership ratio at the Company is 0% due to business sectors with restricted foreign ownership limits.
- During the issuance of bonus shares under the employee stock option program, the Company shall not issue shares to foreign employees, thereby ensuring compliance with the foreign ownership ratio regulations.

*The Board of Directors VII.13 unanimously approved the Plan to Ensure Compliance with Regulations on Foreign Ownership Ratio.*

**Article 4. Assign and authorize the Chairman of the Board of Directors to implement the tasks outlined in this Resolution, including but not limited to the following specific tasks:**

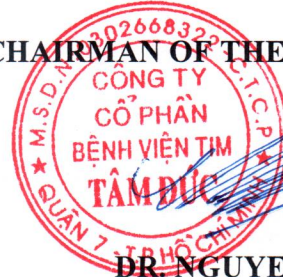
- Register the issuance with the State Securities Commission of Vietnam ("SSC"), select the specific issuance timing after obtaining SSC approval;
- Prepare the dossiers and documents for reporting to the SSC: including but not limited to drafting, amending, and supplementing related documents of the Share Issuance Registration Dossier if requested by the SSC, and other related procedures as prescribed;
- Implement the share issuance after the SSC has issued a document confirming receipt of the comprehensive dossier/report, including but not limited to the issuance announcement, finalizing the shareholder list, and other related procedures;
- Implement the issuance result report after completing the issuance;



- Implement necessary procedures to register the additional issued shares with the Vietnam Securities Depository and Clearing Corporation and register additional trading on the Hanoi Stock Exchange after the issuance is completed in accordance with regulations;
- And other related tasks to complete the share issuance.

*The Board of Directors VII.13 unanimously approved the assignment and authorization for the Chairman of the Board of Directors to implement the aforementioned tasks.*

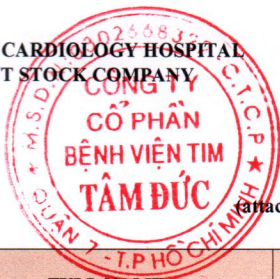
