However, the values presented in the 2024 Corporate Governance Report were provisional values based on the initial contract, whereas the actual values were determined based on actual executed and accepted quantities. Accordingly, following a review, the Company hereby makes these corrections and amendments to ensure the accuracy of the disclosed information.
- With respect to Item 1.13 relating to transactions with Binh Duong ACC Investment and Construction Joint Stock Company, such transactions were carried out in accordance with the duly approved authority and disclosed in accordance with applicable regulations. However, the value presented in the 2025 Corporate Governance Report was a provisional value based on the initial contract, whereas the actual value was determined based on actual executed and accepted quantities.
- With respect to Item 1.25 relating to transactions with Binh Duong ACC Investment and Construction Joint Stock Company, such transactions were carried out in accordance with the duly approved authority. However, the information presented in the Report was a provisional value based on the initial contract, while the final value was determined based on actual executed and accepted quantities.

With respect to Item 2 relating to transactions with An Binh Stone Tile Joint Stock Company, including the collection of electricity payments on behalf of An Binh Stone Tile Joint Stock Company and the Granite – Granodiorite Stone (Block Stone) purchase contract, such transactions were carried out in accordance with the duly approved authority. However, these transactions were omitted from the Company's 2024 Corporate Governance Report.
