**Regarding the approval for the participation in the carbon trading system of PetroVietnam Securities Joint Stock Company.**

*Pursuant to Decision No. 40/QĐ-HĐTV dated May 28, 2026 of the Members' Council of the Vietnam Stock Exchange promulgating the Regulations on trading members for greenhouse gas emission allowances and carbon credits;*

*Upon consideration of the application dossier for participation in the carbon trading system submitted by PetroVietnam Securities Joint Stock Company;*

*At the proposal of the Head of the Membership Management Division,*

**HEREBY DECIDES:**

**Article 1.**

To approve Petrovietnam Securities Joint Stock Company to participate in the carbon trading system.

**Article 2.**

Petrovietnam Securities Joint Stock Company shall comply with the provisions of law on the domestic carbon exchange and the regulations of the Vietnam Stock Exchange.

**Article 3.**

This Decision shall take effect from the date of signing.

The Head of the General Administration Division, the Head of the Membership Management Division, the General Director of Hanoi Stock Exchange, and Petrovietnam Securities Joint Stock Company shall be responsible for the implementation of this Decision.
