Pursuant to Decision No. 01/QĐ-HĐTV dated 30/6/2021 of the Member Council of Vietnam Stock Exchange on the establishment of Hanoi Stock Exchange;

Pursuant to the Charter on the organization and operation of Hanoi Stock Exchange issued together with Decision No. 08/QĐ-HĐTV dated 09/07/2021 of the Member Council of Vietnam Stock Exchange;

Pursuant to the Securities Law No. 54/2019/QH14 dated 26/11/2019;

Pursuant to Decision No. 37/QĐ-SGDVN dated 24/06/2026 of the General Director of Vietnam Stock Exchange on approval for participation in the carbon trading system for Petrovietnam Securities Joint Stock Company;

Considering the connection registration dossier of Petrovietnam Securities Joint Stock Company;

Upon the proposal of the Director of the Derivatives Securities Market Department,

DECIDES:

Article 1. Approve Petrovietnam Securities Joint Stock Company to connect to the carbon market trading at Hanoi Stock Exchange.

Article 2. Petrovietnam Securities Joint Stock Company must comply with the legal regulations on domestic carbon trading floors, regulations on trading and information technology infrastructure connected to Hanoi Stock Exchange.

Article 3. This Decision takes effect from the date of signing. The Director of the General Affairs Department, the Director of the Derivatives Securities Market Department, Heads of affiliated units of Hanoi Stock Exchange and Petrovietnam Securities Joint Stock Company are responsible for implementing this Decision.
