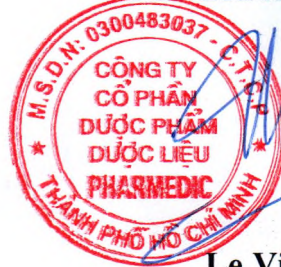

The State Securities Commission of Vietnam ("SSC") has received the dossier for notification of the maximum foreign ownership ratio No. 32/PMC-HĐQT dated 26/05/2026 of Pharmedic Pharmaceutical Medicinal Joint Stock Company ("the Company") (HNX: PMC) at 0%. The SSC provides the following opinions:

1. Organizations and individuals participating in the preparation of the dossier shall be responsible before the law for the legality, accuracy, truthfulness, and completeness of the dossier in accordance with Clause 1, Article 11a of the Law on Securities No. 54/2019/QH14 (as amended and supplemented at Clause 4, Article 1 of Law No. 56/2024/QH15), and shall be responsible for the results of determining the maximum foreign ownership ratio of the Company in accordance with the law.

In the event that the Company's current foreign ownership ratio exceeds the maximum foreign ownership ratio prescribed by law, the Company shall comply with the provisions of Clause 5, Article 139 of Decree No. 155/2020/ND-CP dated 31/12/2020 of Government, detailing the implementation of a number of articles of the Law on Securities, as amended and supplemented by Decree No. 245/2025/ND-CP.

2. The SSC requests the Company to fulfill its information disclosure obligations in accordance with Clause 2, Article 13 of Circular No. 96/2020/TT-BTC dated 16/11/2020 of the Minister of Finance guiding information disclosure on the securities market, and to comply with legal regulations on the maximum foreign ownership ratios in the Vietnamese securities market.

3. The Viet Nam Securities Depository and Clearing Corporation shall update and adjust the Company's maximum foreign ownership ratio in accordance with Clause 4, Article 142 of Decree No. 155/2020/ND-CP, as amended and supplemented by Decree No. 245/2025/ND-CP.

The SSC hereby notifies the Company, the Viet Nam Securities Depository and Clearing Corporation, and relevant entities for their information and implementation in accordance with applicable regulations.
