The Company's Q2/2026 business results recorded a loss and a decrease of 689%, equivalent to a decline of VND 17,885,736,940 over the same period last year, mainly due to the following material reasons:

- Interest expenses in Q2/2026 increased by 789% (equivalent to an increase of VND 15,388,762,407) compared to the same period in 2025 due to the Company's recognition of interest expenses on its current outstanding debt,
- Net revenue from sales and service provision in Q2/2026 decreased by 20% (equivalent to a decline of VND 6,079,553,480) compared to the same period in 2025 due to the adverse impact of market difficulties,
- Other profit in Q2/2026 decreased by 109% (corresponding to a decline of VND 1,277,204,136) compared to the same period in 2025 due to the fact that in Q2/2025, the Company recorded other profit from the liquidation of assets, However, in Q2/2026, this extraordinary income did not recur,

Beton 6 Corporation would like to submit this report and explanation to the State Securities Commission and the Stock Exchange.
