3. Supervision over the Board of Management by the BOD:

In the first six months of 2026, the BOD fulfilled its functions and responsibilities as stipulated in the Articles of Incorporation of 36 Corporation, specifically:

- The BOD actively followed the Resolutions of the General Meeting of Shareholders to closely and properly direct the Corporation's production and business activities and effectively implement the established policies, measures, and strategies. At the same time, the BOD inspected and supervised the Board of Management in implementing the Resolutions and Decisions of the BOD.

- The BOD maintained regular meetings as prescribed and held extraordinary meetings when necessary (09 meetings) to formulate policies and solutions for addressing issues related to the development strategy and implementation of the production and business plan. The BOD issued resolutions and decisions that received a high level of consensus at its meetings and promptly introduced effective solutions to address difficulties arising during the Board of Management's administration of the Corporation's production and business activities. The decisions covered the following matters:

- + Approval of transactions between the Corporation and related parties;
- + Provisioning and reversal of reserves by 36 Corporation;
