Based on the Financial Statements of Quarter 2, 2026, IDICO Investment
Construction Oil and Natural Gas Joint Stock Company would like to explain the
changes in profit after tax on the Financial Statements of Quarter 2, 2026
compared to the same period last year, specifically as follows:

- Profit after tax in the Income Statement of Quarter 2, 2026 of IDICO
Investment Construction Oil and Natural Gas Joint Stock Company decreased
compared to the same period last year: - 69,645 million VND (15,282 million VND
- 84,927 million VND), in which:

Profit after tax in Quarter 2, 2025: 84,927 million VND

Profit after tax in Quarter 2, 2026: 15,282 million VND

Reason: Net profit after tax in Q2 2026 decreased compared to the same period
last year mainly because in Q2 2026, revenue from real estate business of the
Investment Project to build a commercial, service and residential complex in the
North Chau Giang Urban Area was low, and there was no revenue from leasing the
infrastructure of My Xuan B1 Industrial Park, which was recorded as a one-time
revenue as was done in Q2 2025.

The above is the explanation of IDICO Investment Construction Oil and
Natural Gas Joint Stock Company on the change in profit after tax in the Financial
Statements of Quarter 2, 2026 compared to Quarter 2, 2025.
