The company is still striving to maintain production and business operations. The output of the renewable energy sector has decreased due to some policy obstacles, affecting the implementation of some wind power projects. Depreciation and fixed labor costs remain high, while some wind power projects have temporarily suspended operations, leading to a decrease in revenue and after-tax profit.
