3. Board of Directors' oversight of the Executive Board:

Based on the Company's Charter, the Board of Directors has supervised the activities of the Executive Board in organizing and managing production and business operations and implementing resolutions of the General Meeting of Shareholders and resolutions of the Board of Directors.

The Board of Directors always adheres closely to the resolutions of the General Meeting of Shareholders to strictly direct the Company's production, business, and investment activities. At the same time, it regularly checks and monitors the business performance of the Executive Board.

Supervision activities are carried out regularly, promptly, and comprehensively. In addition to regular meetings, the Executive Board also regularly reports and exchanges information with the Board of Directors to promptly and effectively address emerging issues.

The Company's Board of Directors has organized regular and extraordinary meetings in an expanded format, soliciting opinions in writing for the participation of Executive Board members, the Supervisory Board, and specialized departments, in accordance with the Company's Charter, closely adhering to and strictly implementing the resolutions of the General Meeting of Shareholders.

The Board of Directors proactively assessed the market and, based on the Company's business situation, issued resolutions and decisions to guide the Executive Board's operations. In the first six months of 2026, the Board of Directors discussed and decided on important issues related to the Company's operations, outlining measures to achieve the plan's objectives.

The Board continued to strengthen management and strive for efficient production and business operations. It also directed the Executive Board to strictly comply with legal regulations regarding capital investment and regular procurement to maintain the Company's ongoing operations.

According to the Board of Directors' assessment, the Executive Board's activities in implementing the production and business plan in the first six months of 2026 were consistent with the Shareholders' General Meeting Resolution, the Board of Directors' Resolution, the actual market situation, and legal regulations. The management team demonstrated strong determination in leadership and management, along with flexibility and adaptability during implementation, enabling the company to overcome difficulties arising from market competition and gradually achieve its set goals.

The Board of Directors highly appreciates the decisive leadership, practical actions, and correct direction of the General Director's Board regarding production and business operations amidst volatile and unstable Middle Eastern market conditions, high raw material prices, and lagging selling prices. Despite these challenges, all production and business performance indicators for the first six months of 2026 exceeded 50% of the planned targets.

4. Activities of the Board of Directors' Subcommittees (if any): The internal audit subcommittee's activities from its establishment on February 11, 2024 to the present and during the first six months of 2026 have fully performed its functions and duties as stipulated in the Subcommittee's organizational and operational regulations.

The Subcommittee's activities during the first six months of 2026 were solely supervisory; no unusual incidents were detected.

The Supervisory Board also noted the Executive Board about the risks related to legal lawsuits with partners, and proposed to have a handling plan to protect the interests of the Company.
