I. Activities of the General Meeting of Shareholders:

1. Extraordinary General Meeting of Shareholders

On February 5, 2026, the General Meeting of Shareholders held an extraordinary meeting to approve the following matters:

+ The policy for participating in a consortium with Vietnam Maritime Corporation - JSC (VIMC) and Mediterranean Shipping Company (MSC)/Terminal Investment Limited Holding (TiL), or another entity designated by the MSC/TiL Group, to register for investor selection for the Can Gio International Transshipment Port Project.

+ The policy permitting Saigon Port Joint Stock Company to contribute capital equivalent to 15% of the charter capital of the joint venture company, together with VIMC and MSC/TiL, or another entity designated by the MSC/TiL Group, to implement the Can Gio International Transshipment Port Project.

+ Approval of amendments and supplements to certain provisions of the Charter of Saigon Port Joint Stock Company.

2. 2026 Annual General Meeting of Shareholders

On 24 April 2026, Saigon Port successfully held the 2026 Annual General Meeting of Shareholders.
