The State Securities Commission (SSC) has received the registration dossier for the private placement of shares of Phu Hung Securities Corporation (the "Company"), as submitted under Application No. 246/2026/PHS-TV dated July 22, 2026. The SSC has the following comments:

1. Organizations and individuals participating in the preparation of dossiers and reporting documents related to securities and securities market activities shall be legally liable for the legality, accuracy, truthfulness, and completeness of such dossiers and documents; organizations and individuals participating in the certification of dossiers and reporting documents shall be legally liable within the scope related to such dossiers and documents, in accordance with Clause 1, Article 11a of the Law on Securities, as added by Clause 4, Article 1 of Law No. 56/2024/QH15.
2. The SSC has announced on its website that it has received the Company's application for private placement of shares. The Company's private placement of shares is carried out in accordance with the plan in the Resolution of the General Meeting of Shareholders No. 01/2026/NQ-ĐHĐCĐ dated April 16th, 2026, the Resolution of the Board of Directors No. 05/106_0626/NQ-HĐQT dated May 26th, 2026 and the provisions of law.
3. Within 10 days from the date the offering concludes, the Company is required to submit a report on the offering results - accompanied by confirmation from the bank holding the escrow account regarding the proceeds - to the SSC and to disclose the results on the Company's website and the Stock Exchange's website, in accordance with Clause 4, Article 48 of the Government's Decree No. 155/2020/ND-CP dated December 31, 2020, detailing the implementation of a number of articles of the Law on Securities.

The State Securities Commission hereby notifies the Company for its information./.
