Pursuant to Notice No.2791/TB-VSDC dated June 30, 2026 of the Vietnam Securities Depository and Clearing Corporation regarding the record date and confirmation of the list of security holders, and the Master List of Security Holders Receiving Cash Dividends No. VNDVCAVSDK019512/VSDKHWXX as of the record date of July 14, 2026, prepared by the Vietnam Securities Depository and Clearing Corporation on July 15, 2026. Khanh Hoa Water Supply and Sewerage Joint Stock Company hereby announces the payment of the 2025 cash dividend to the shareholders of the Company as follows:

1. Dividend rate: 17,5 % / share;
2. Payment time: August 28, 2026;
3. Dividend payment method:
 - a. For the dividends payable to 87 deposited shareholders, after deducting 5% Personal Income Tax, the Company shall transfer the entire remaining dividend amount to the Vietnam Securities Depository and Clearing Corporation, totaling VND 626.523.092 (Six hundred twenty-six million five hundred twenty-three thousand ninety-two Vietnam Dong);
 - b. For dividends payable to undeposited individual shareholders, after withholding 5% Personal Income Tax as required by regulations, Khanh Hoa Water Supply and Sewerage Joint Stock Company shall make cash dividend payments at the Company's headquarters, with a total amount of VND 1.806.439.250 (One billion eight hundred six million four hundred thirty-nine thousand two hundred fifty Vietnam Dong).



At the time of dividend collection, shareholders shall present a valid Citizen Identification Card, or Passport to complete the payout procedure; **proxy payments shall not be processed.**

- c. For dividends on State-owned capital, the Company shall declare and remit to the State Budget of Khanh Hoa Province;
- d. For dividends payable to REE Clean Water Co., Ltd, the payment shall be transferred to the registered bank account for dividend receipt.
