Pursuant to Enterprise Law No. 59/2020/QH14 dated 17/6/2020; Law No. 76/2025/QH15 dated 17/6/2025 on amending and supplementing the Enterprise Law;

Pursuant to the Charter of Organization and Operation of Vicem Gypsum and Cement Joint Stock Company (the Company);

Pursuant to the Regulations on Procurement of Goods and Services issued by the Company enclosed with Decision No. 1748/QĐ-HĐQT, dated 26/12/2025 of the Board of Directors;
