The State Securities Commission (SSC) received Dossier No. 2707/2026/TB-DHP dated July 27th, 2026, announcing the maximum foreign ownership limit (FOL) of Haiphong Electromech Joint Stock Company (the Company) (HNX: DHP) at 0%. The SSC has the following opinions:

1. Organizations and individuals involved in the preparation of the dossier shall be legally responsible for the legality, accuracy, truthfulness, and completeness of the dossier pursuant to Clause 1, Article 11a of Securities Law No. 54/2019/QH14 as amended and supplemented by Law No. 56/2024/QH15, and shall be responsible for the results of reviewing the maximum foreign ownership limit at the Company in accordance with the law.

In the event that the Company's current foreign ownership percentage exceeds the legally prescribed foreign ownership limit, the Company must comply with Clause 5, Article 139 of Decree No. 155/2020/ND-CP detailing the implementation of a number of articles of the Securities Law as amended and supplemented by Decree No. 245/2025/ND-CP.

2. The SSC requests the Company to fulfill its information disclosure obligations in accordance with Clause 2, Article 13 of Circular No. 96/2020/TT-BTC guiding the disclosure of information on the stock market, as amended and supplemented by Circular No. 68/2024/TT-BTC, Circular No. 18/2025/TT-BTC, and to comply with legal regulations regarding foreign ownership limits in the Vietnamese stock market.
3. Viet Nam Securities Depository and Clearing Corporation shall update and adjust the maximum foreign ownership limit for the Company on the system in accordance with Clause 4, Article 142 of Decree No. 155/2020/ND-CP
