DECISION
On the Suspension of Judgment Enforcement

HEAD OF THE CIVIL JUDGMENT ENFORCEMENT AGENCY

Pursuant to Clause 2, Article 22 and Clause 6, Article 62 of the Law on Civil Judgment Enforcement No. 106/2025/QH15;

Pursuant to Judgment No. 18/2024/QĐST-DS dated 23 August 2024 of the People's Court of Vung Tau City, Ba Ria – Vung Tau Province (now the People's Court of Region 11, Ho Chi Minh City);

Pursuant to the judgment enforcement decision upon request No. 944/QĐ-CCTHADS dated 02 December 2024 of the Civil Judgment Enforcement Sub-Department of Vung Tau City, Ba Ria – Vung Tau Province (now the Civil Judgment Enforcement Agency of Ho Chi Minh City);

Pursuant to Authorization Decision No. 1107/QĐ-THADS dated 29 June 2026 regarding the authorization to sign and issue decisions on judgment enforcement by the Head of the Civil Judgment Enforcement Agency of Ho Chi Minh City;

Pursuant to Decision No. 08/2026/QĐ-BPKCTT dated 29 July 2026 of the People's Court of Region 11, Ho Chi Minh City, on the cancellation of a provisional emergency measure;

Having considered the proposal of the assigned Enforcement Officer in charge of organizing the judgment enforcement.

HEREBY DECIDES:

Article 1. Suspension of judgment enforcement against: Petroleum Equipment Assembly & Metal Structure Joint Stock Company (PVC-MS), address: No. 02 Nguyen Huu Canh Street, Thang Nhat Ward, Vung Tau City, Ba Ria – Vung Tau Province (now Rach Dua Ward, Ho Chi Minh City).

The enforcement measures to be suspended are as follows:

1. Cancellation of the provisional emergency measure of “freezing Account No. 100003797979” opened at National Citizen Commercial Joint Stock Bank (NCB) – Ba Ria – Vung Tau Branch in the name of Petroleum Equipment Assembly & Metal Structure Joint Stock Company, with the frozen amount of VND 18,896,190,263 (in words: Eighteen billion, eight hundred ninety-six million, one hundred ninety thousand, two hundred sixty-three Vietnamese dong).

2. Cancellation of the provisional emergency measure of “freezing Account No. 5511100683008” opened at Military Commercial Joint Stock Bank (MB Bank) – Vung

Tau Branch in the name of Petroleum Equipment Assembly & Metal Structure Joint Stock Company, with the frozen amount of VND 18,896,190,263 (in words: Eighteen billion, eight hundred ninety-six million, one hundred ninety thousand, two hundred sixty-three Vietnamese dong).

The above-mentioned two provisional emergency measures were imposed by the People's Court of Vung Tau City, Ba Ria – Vung Tau Province pursuant to Decision No. 07/2024/QĐ-BPKCTT dated 09 July 2024 and Decision No. 08/2024/QĐ-BPKCTT dated 12 July 2024.

These measures were imposed in civil case No. 29/2024/TLST-KDTM dated 07 March 2024 concerning a “Dispute over a Service Contract” between the plaintiff, Industrial Company Limited, and the defendant, Petroleum Equipment Assembly & Metal Structure Joint Stock Company.

Article 2. The assigned Enforcement Officer responsible for organizing the judgment enforcement, the judgment debtor, the judgment creditor, and other persons having related rights and obligations shall be responsible for implementing this Decision.

Article 3. This Decision shall take effect from the date of signing.
