**RESOLUTION**

Re: Approval of the guarantee issuance arrangement with the Joint Stock Commercial Bank for Investment and Development of Vietnam – Ha Dong Branch (BIDV Ha Dong)

HEREBY RESOLVES**Article 1. Approval of the guarantee issuance arrangement at BIDV Ha Dong**

The Board of Directors hereby approves the guarantee issuance arrangement at BIDV Ha Dong with the principal terms and conditions set out below:

- Types of guarantees: bid guarantee, performance guarantee, advance payment guarantee, warranty guarantee, and other guarantees arising in the ordinary course of the Company's business operations.
- Guarantee facility limit: **VND 1,100,000,000,000 (in words: One trillion one hundred billion Vietnamese dong only).**

Article 2. Authorization and implementation

- Mr. Nguyen Cong Hung, Chairman of the Board of Directors of SCI Joint Stock Company, is hereby authorized to act on behalf of the Company to directly negotiate and execute the guarantee agreement with BIDV Ha Dong Branch, and to perform all necessary procedures in relation thereto. He shall be the Company's duly authorized representative with full authority to use the Company's assets and to receive assets from the obligor for pledge or mortgage as security at BIDV Ha Dong.

Article 3. Effectiveness and implementation responsibility

- This Resolution shall come into force as from the date of signing.
- Members of the Board of Directors and all relevant departments, units, and individuals shall be responsible for implementing this Resolution.
