The State Securities Commission (SSC) has received the notification dossier on the maximum foreign ownership limit (FOL) of 0% at Son La Sugar Joint Stock Company (HNX: SLS/the Company). The SSC hereby gives the following opinions:

1. Organizations and individuals involved in the process of preparing the dossier shall be held legally responsible for the legality, accuracy, truthfulness, and completeness of the dossier pursuant to Clause 1, Article 11a of the Law on Securities No. 54/2019/QH14 (as amended and supplemented by Law No. 56/2024/QH15) and shall be responsible for the results of reviewing the maximum FOL at the Company in accordance with applicable laws.

In the event that the Company's current foreign ownership ratio exceeds the statutory foreign ownership limit, the Company must comply with the provisions of Clause 5, Article 139 of the Government's Decree No. 155/2020/NĐ-CP dated December 31, 2020, detailing the implementation of a number of articles of the Law on Securities (Decree No. 155/2020/NĐ-CP), as amended and supplemented by Decree No. 245/2025/NĐ-CP.

2. The SSC requests the Company to fulfill its information disclosure obligations in accordance with Clause 2, Article 13 of Circular No. 96/2020/TT-BTC guiding information disclosure on the securities market (as amended and supplemented by Circular No. 68/2024/TT-BTC and Circular No. 18/2025/TT-BTC), and to comply with legal regulations on foreign ownership limits on the Vietnamese stock market.

3. Vietnam Securities Depository and Clearing Corporation shall perform updates and adjustments on the system regarding the maximum FOL at the Company pursuant to Clause 4, Article 142 of Decree No. 155/2020/NĐ-CP, as amended and supplemented by Decree No. 245/2025/NĐ-CP.

The SSC hereby notifies the Company, Vietnam Securities Depository and Clearing Corporation, and relevant units for their information and execution in accordance with the regulations./.
