Pursuant to the Government's Decree No. 155/2020/ND-CP dated December 31, 2020, providing detailed regulations for implementation of a number of articles of the Law on Securities;

Pursuant to the Government's Decree No. 245/2025/ND-CP dated September 11, 2025, amending and supplementing a number of articles of Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government providing detailed regulations for implementation of a number of articles of the Law on Securities;

Pursuant to Decision No. 07/QĐ-HĐTV dated July 9, 2021 of the Members' Council of Vietnam Stock Exchange promulgating the Charter on organization and operation of Ho Chi Minh City Stock Exchange;

Pursuant to Decision No. 22/QĐ-HĐTV dated March 16, 2026 of the Members' Council of Vietnam Stock Exchange promulgating the Regulation on Listing and Trading of Listed Securities;

Having considered the application for registration for listing of shares of Viet Nam Eco Plastic Technology Joint Stock Company;

HEREBY DECIDES:

Article 1. To approve the registration for listing of shares of:
