to the Head Office or another unit, so as to ensure that no damage is caused to existing obligations towards the State, the interests of policyholders, insureds, and other related organizations and individuals; and for transferring deposits/guarantees from the bank accounts of the member units/branches to the Corporation's bank account for continued monitoring.

Article 3: This Resolution takes effect from the date of signing. Members of the Board of Directors, the Executive Board, and other relevant units and individuals are responsible for the implementation of this Resolution.
