Based on the Vote Counting Minutes of collecting shareholders' written opinions dated September 18, 2026, and the Resolution of the General Meeting of Shareholders dated September 18, 2026, Ben Thanh Water Supply Joint Stock Company announces the results of collecting shareholders' written opinions as follows:

1. Dismissal of Mr. Pham Tuan Anh from the Board of Directors for the 2022–2027 term at the request of the shareholder, Saigon Water Corporation – One Member Limited Liability Company, due to a change in their capital representative at the Company.

Based on the vote counting results, the above content was approved by the General Meeting of Shareholders with 8.953.061 voting shares in favor, accounting for 95,65% of the total voting shares of all shareholders with voting rights, satisfying the conditions for approval according to the Company's Charter.

2. Dismissal of Ms. Nguyen Thi Kieu Nguyet from the Board of Directors for the 2022–2027 term according to her Application for Resignation from the Board of Directors.

Based on the vote counting results, the above content was approved by the General Meeting of Shareholders with 8.953.061 voting shares in favor, accounting for 95,65% of the total voting shares of all shareholders with voting rights, satisfying the conditions for approval according to the Company's Charter.

RESOLVES

Article 1. Dismissal of members of the Board of Directors.

1. Approve the dismissal of Mr. Pham Tuan Anh from the Board of Directors of Ben Thanh Water Supply Joint Stock Company for the 2022 - 2027 term at the request of the shareholder, Saigon Water Corporation - One Member Limited Liability Company, due to a change in their capital representative at the Company.

2. Approve the dismissal of Ms. Nguyen Thi Kieu Nguyet from the Board of Directors of Ben Thanh Water Supply Joint Stock Company for the 2022 - 2027 term according to her Application for Resignation from the Board of Directors.

Article 2. Acknowledgment of the supplementary election results for members of the Board of Directors.



Acknowledge the supplementary election results for 02 members of the Board of Directors of Ben Thanh Water Supply Joint Stock Company for the remaining period of the 2022 - 2027 term under the cumulative voting method specified in Clause 3, Article 148 of the 2020 Law on Enterprises, specifically:

a) Ms. Tran Thi Ngoc Luyen is elected as a member of the Board of Directors of Ben Thanh Water Supply Joint Stock Company for the remaining period of the 2022 - 2027 term.

b) Ms. Nguyen Do Ngoc Bao is elected as a member of the Board of Directors of Ben Thanh Water Supply Joint Stock Company for the remaining period of the 2022 - 2027 term.

Article 3. Approval of the 2026 clean water wholesale contract transaction, the authorization for implementation and related payment mechanism.

1. Approve the negotiation of the Agreement and the signing of the 2026 clean water wholesale contract between the Company and the Corporation with a unit price excluding value-added tax of 7,455.49 VND/m³; the agreement and the clean water wholesale contract shall be signed on a yearly basis and assigned to the Director of the Company for implementation.

2. Authorize the Board of Directors to approve the policy of negotiating and signing the amended Agreement and clean water wholesale contract in the event of a unit price change. In case the adjustment results in a difference in the post-adjustment transaction value compared to the transaction approved by the General Meeting of Shareholders being less than 35% of the total asset value according to the latest Financial Statements of the Company, the Board of Directors is responsible for reporting the implementation results of the authorized contents at the 2027 Annual General Meeting of Shareholders.

3. The General Meeting of Shareholders approves the policy of allowing the Director (Legal Representative) of the Company to make advance payments for clean water wholesale purchases in 2027 according to the applicable unit price of the 2026 clean water wholesale contract while waiting for the General Meeting of Shareholders to decide on the 2027 clean water wholesale contract transaction and applicable unit price, in order to ensure the safe, continuous, and stable production, business, and water supply operations of the Company.

Article 4. Implementation.

1. This Resolution takes effect from the date of approval by the General Meeting of Shareholders of Ben Thanh Water Supply Joint Stock Company in the form of collecting shareholders' written opinions.

2. The Board of Directors, the Supervisory Board, the Director of the Company and related organizations and individuals are responsible for implementing this Resolution.
