4. The Corporation is responsible for ensuring that the termination of the branches' operations does not cause damage to its existing obligations to the State, the interests of policyholders and other related parties, in accordance with Point b, Clause 1, Article 25 of Decree No. 46/2023/ND-CP.

The Insurance Supervisory Authority hereby notifies the Corporation for its information and implementation in accordance with the law./.
