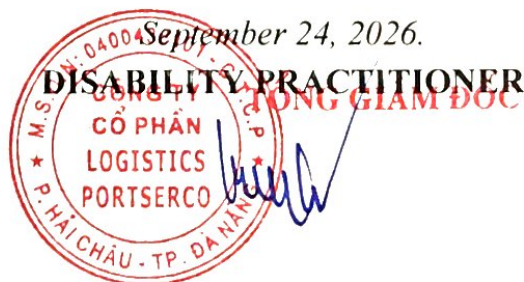

Pursuant to Decree No. 155/2020/ND-CP dated 31 December 2020 of the Government detailing the implementation of a number of articles of the Securities Law, as amended and supplemented by Decree No. 245/2025/ND-CP dated 11 September 2025;

Pursuant to Circular No. 118/2020/TT-BTC dated 31 December 2020 of the Minister of Finance guiding a number of matters concerning the offering and issuance of securities, tender offers, share buy-backs, registration of public companies and revocation of public company status, as amended and supplemented by Circular No. 115/2025/TT-BTC dated 15 December 2025;

Pursuant to Decision No. 686/QD-BTC dated 28 February 2025 of the Ministry of Finance defining the functions, tasks, powers and organizational structure of the State Securities Commission;

Considering the application for registration of an additional public offering of shares of Portserco Logistics Joint Stock Company;

At the request of the Head of the Securities Offering Management Department,

DECIDES:

Article 1. To grant the Certificate of Registration for an Additional Public Offering of Shares to:

PORTSERCO LOGISTICS JOINT STOCK COMPANY

- Name in a foreign language: PORTSERCO LOGISTICS JOINT STOCK COMPANY.
- Abbreviated name: PORTSERCO.
- Head office: No. 59 Ba Dinh, Hai Chau Ward, Da Nang City.
- Enterprise Registration Certificate of the joint stock company, enterprise code 0400438101, first issued by the Da Nang City Department of Planning and Investment on 26 December 2002, with the 18th amended registration issued by the Da Nang City Department of Finance on 08 May 2026.
- Charter capital: VND 61,996,980,000 (In words: sixty-one billion, nine hundred and ninety-six million, nine hundred and eighty thousand Vietnamese dong).

Article 2. The shares of Portserco Logistics Joint Stock Company shall be additionally offered to the public on the following terms:

1. Type of shares: Ordinary shares;
2. Par value per share: VND 10,000 (In words: ten thousand dong);
3. Total number of shares offered: 6,199,698 shares (In words: six million, one hundred and ninety-nine thousand, six hundred and ninety-eight shares);
4. Total value of the offered shares at par value: VND 61,996,980,000 (In words: sixty-one billion, nine hundred and ninety-six million, nine hundred and eighty thousand Vietnamese dong);
5. Distribution period: Within 90 days from the effective date of the Certificate of Registration for an Additional Public Offering of Shares;
6. Distribution method: As set out in the Prospectus;
7. Advisory organization: Agribank Securities Joint Stock Company.



Article 3. Portserco Logistics Joint Stock Company, and the organizations and individuals involved in the application, shall comply with the provisions of Article 11a of the Securities Law and Clause 1, Article 6 of Decree No. 155/2020/ND-CP dated 31 December 2020, as amended and supplemented by Point b, Clause 3, Article 1 of Decree No. 245/2025/ND-CP dated 11 September 2025.

Article 4. The State Securities Commission shall receive and process the application in accordance with Clause 2, Article 11a of the Securities Law and Point d, Clause 1, Article 6 of Decree No. 155/2020/ND-CP dated 31 December 2020, as amended and supplemented by Point b, Clause 3, Article 1 of Decree No. 245/2025/ND-CP dated 11 September 2025.

Article 5. This Certificate is made in five (05) original copies (of which: 01 copy is issued to Portserco Logistics Joint Stock Company, 02 copies are retained at the State Securities Commission, 01 copy is sent to the Hanoi Stock Exchange, and 01 copy is sent to the Vietnam Securities Depository and Clearing Corporation) and takes effect from the date of signing.
