**Article II:** Mr Nguyen Thanh Hung is responsible for exercising the rights and performing the obligations of the Company's Director in accordance with the provisions of Law and the Company's Charter.

- Benefits: Monthly salary: VND 50,381,370 /month.  
+ The Director's salary expense is included in the total approved payroll unit cost.



- Insurance benefits for which the Company is responsible under Clause 3, Article 168 of the Labor Code No. 45/2019/QH14 dated 20 November 2019 shall be fixed based on the salary used for insurance contributions applicable to the Director position as registered by the Company with the social insurance authority: VND 4,381,700/month.

- Other benefits in addition to salary:

o Industrial meal: according to the Company's salary regulations;

o Salary and bonuses for public holidays and Tet holidays funded from the payroll fund shall be paid in accordance with the Company's Salary Regulations applicable to the Director position.

o Salary, bonuses for Public Holidays and Tet holiday from the salary fund shall be implemented in accordance with the Company's Salary Regulations applicable to the Director position.

- Annual leave: Mr. Nguyen Thanh Hung is entitled to 12 days of annual leave per calendar year. Annual leave pay shall be implemented in accordance with the Company's Salary Regulations applicable to the Director position.

The above benefits shall be adjusted and updated when the Company issues new policies on salary scales and payrolls for job positions.
